The annual Clinton County Association of Township Officials convention has been scheduled for **June 6th, 2024** from 9:00AM -3:00PM. Once again the convention will be held at the Clinton County Fairground, 98 Racetrack Road, Mill Hall, PA 17751.

The association is hosting a local government trade show inviting businesses to promote and showcase their equipment and service/products. The convention offers an opportunity to the 21 townships of Clinton County to network together by providing a wide range of speakers to inform local government with the most current information, introduce new businesses and new ideas to municipalities. Elected officials, employees, auditors, tax collectors, solicitors and engineers are invited to enjoy a day filled with information from exhibits, speakers presenting updated information from state, county and local levels, equipment competition, food and games.

Again this year we will offer an equipment competition. Township employee equipment operators are encouraged to register and compete to win prizes showing their skills and ability they use to operate equipment in townships. There will be workshops offered, raffle drawings, 50/50, a trivia game of jeopardy to enjoy the events of the day.
